RELEASE FROM LIABILITY

The undersigned owner and/or driver, by signing this application in consideration of the membership card issuance for the required fee, does agree to assume all responsibility and liability for all acts or activities of said owner and/or driver and all his/her assistants and crew, and for any and all damage or injury that may be caused by any or all of them or by his/her car or other property or possessions. The undersigned does hereby release the 600 Micro Sprint, USA and any organization sponsoring or assisting in promoting or conducting a race sanctioned by the said association, together with their successors assigns, officers, agent assistants, representatives, employees and spectators attending said race, from any and all liability claims, demands and causes of action whatsoever which the undersigned may have or may accrue in his/her favor against them or any or either of them in any way growing out of or resulting from said race or any part thereof, or in connection with any equipment or facility provided or used, whether or not the same may be operated or controlled by them, and whether arising while in preparation or practice previous to the race, or while participation therein, or subsequent thereto. The undersigned assumes agreement, whether oral or written, shall in any way affect this release. Furthermore the undersigned certifies to the truth of all statements made in this application, and agrees to abide by all rules and to accept, as final, all decisions of properly authorized race officials. I agree that all decisions of 600 Micro Sprint, USA race officials, or track officials, regarding the interpretation and application of the 600 Micro Sprint, USA rules, and the scoring of positions, shall be non-litigable. I further covenant and agree that I will not initiate any type of legal action against 600 Micro Sprint, USA or any 600 Micro Sprint, USA promoter, to challenge such decisions, to seek monetary damages, to seek injunctive relief or to seek any other kind of legal remedy. I understand that if I pursue any legal action, which violates this provision, then I expressly agree to reimburse 600 Micro Sprint, USA or the 600 Micro Sprint, USA promoter, for all of its attorney's fees and costs in defending against such legal action. I further understand that if I pursue any such legal action that my membership, should a membership card be issued, would be immediately forfeited and future membership in the 600 Micro Sprint, USA may be denied regardless of the outcome of my legal action. I further understand that there is no express or implied warranty of safety resulting from publication of compliance with the 600 Micro Sprint, USA rules and that they are intended as a guide for the conduct of the sport and are in no way a guarantee against injury or death to participants, spectators or others. I agree that any controversy between myself and parties who are members at the time such controversy arose and which arises out of 600 Micro Sprint, USA business of such parties shall be submitted to binding arbitration. Said arbitration will be pursuant to rules provided by the American Arbitration Association and shall comply with mandatory provision of the Uniform Arbitration Act of Illinois. All binding arbitration is to take place within 100 miles of Marion, Illinois. In consideration of membership card issuance, I agree to arbitrate all such disputes with other members in accordance with these provisions and further agree and obligate myself to abide by and perform any awards made there under. I understand that membership in the Rules by which the 600 Micro Sprint, USA is interpreted, applied or executed are governed by the laws of the State of Illinois in the United States other than choice of law rules. I consent to the exclusive jurisdiction of the U.S. District Court for the Southern District of Illinois in the Circuit Court of the First Judicial Circuit, State of Illinois, and for all disputes arising under this application.
